#### Advertisement for Recruitment of Visiting Professor

Indian Institute of Information Technology Ranchi an Institute of National Importance under Ministry of Education, Government of India invites applications for Visiting Professor positions from distinguished Professors, scientists and industry professionals (both serving and retired from active service), who will bring reputation to the institute, add valuable expertise and practical knowledge and complement the knowledge pool of existing faculty.

The terms and conditions are as follows;

1. The post will carry a consolidated honorarium of ₹ 100000/- (one lakh) per month.
2. The Visiting professor should be actively engaged in teaching and research in his/her tenure.
3. The Visiting Professor will be required to share Administrative work if assigned by the competent authority.
4. The Visiting Professor will be required to undertake normal academic load.
5. The Visiting Professor will be expected to participate in sponsored research and consultancy activities in association with regular faculty members of the Institute.

#### ABOUT THE INSTITUTE

Indian Institute of Information Technology Ranchi is an autonomous institute setup by the MoE, Government of India, and Government of Jharkhand along with the industry partners Tata Technologies Limited, TCS and CCL on a Public Private Partnership.

MoE, Government of India has taken up the initiative to setup 20 new Indian Institutes of Information Technology (IIITs) on a Public Private Partnership Model. A major objective in establishing IIITs is to set up a model of education which can produce best-in-class human resources in IT and harnessing the multi-dimensional facets of information technology in various domains. ### **GENERAL INSTRUCTIONS AND INFORMATION**

- (a) Applications (both soft copy and hard copy) received up to **January 31<sup>st</sup>, 2024** will be processed for this round. Applications received after the due date will not be considered in this round and IIIT Ranchi will not be responsible for any delay.
- (b) The minimum qualification is the minimum criteria only for deciding the eligibility. This shall not ensure short-listings for Interview / Selections. A short-listing criterion may be set higher than the minimum advertised.
- (c) The duly completed application form along with self-attested copies of relevant testimonials, certificates, enclosures, fee transaction slip and other supporting documents are required to be sent by **email and speed post**.

Scanned Copy of filled-in prescribed application form with supporting documents in **single PDF file** may be sent to Email: [establishment@iiitranchi.ac.in](mailto:establishment@iiitranchi.ac.in). The subject of the email should be super scribed as "APPLICATION FOR THE POST OF VISITING PROFESSOR".

Candidate should send the Hard Copy of filled-in prescribed application form with supporting documents by Speed Post to the **Registrar, Indian Institute of Information Technology Ranchi, Science and Technology Campus, Sirkha Toli, Namkum, Ranchi- 834010, India**. The envelope containing the application should be super scribed as "APPLICATION FOR THE POST OF VISITING PROFESSOR".

**Incomplete applications, printed applications submitted without signature on each page, applications which are not clearly legible, application not received in single PDF file (for email mode application), application submitted without processing fees, applications submitted without supporting documents, will not be placed before Scrutiny Committees and the same will be treated as rejected.**

- (d) Applications, which are not in prescribed form / without relevant supporting enclosures and

- fee, shall be summarily rejected. No correspondence shall be entertained in this regard.
- (e) Candidates shall indicate two references of eminent persons in the field / profession, who may be contacted by the Institute for their recommendations.
  - (f) The Institute has the right to set higher norms than minimum while shortlisting, taking into account the specific requirements of the Institute and shall be binding on all the applicants. The short-listing norms may not be uniform across the posts of the institute. The decision of the Institute related to all matters pertaining to the recruitment shall be final and binding on the applicants.
  - (g) The date for determining eligibility of candidates for qualifications, and preferred age limit etc. shall be considered as on the closing date, i.e. the last date of the submission of application form.
  - (h) The short-listed candidates may be required to appear for Skype Interview/ Presentation/Written Test in the respective departments, in addition to facing the Selection Committee. **No TA/DA will be paid for attending Presentation/Written Test/Interview.**
  - (i) Original documents along with one set of self-attested copies will have to be produced at the time of interview for verification.
  - (j) The applicants are advised/required to visit the Institute website: **www.iiitranchi.ac.in** regularly. The list of candidates short listed for further participation in the selection process such as Skype Interview/ Presentation/Written Test/Interview etc. will be displayed on the above website. No separate communication/intimation in this regard shall be made by the Institute.
  - (k) Legal disputes, if any, with IIIT Ranchi will be restricted within the jurisdiction of Ranchi High Court only.

#### **DOCUMENTS / CERTIFICATES:**

Self-attested copies of the following Documents/Certificates are required to be attached along with Application form.

- (a) Matriculation / 10<sup>th</sup> Standard or equivalent certificate indicating date of birth, or mark sheet of Matriculation / 10<sup>th</sup> Standard or equivalent issued by Central / State Board indicating date of Birth will be considered in support of their claim of age. Where date of birth is not available in certificate / mark sheets, issued by concerned Educational Boards, School leaving certificate indicating date of birth will be considered.
- (b) Certificates and mark sheets of all educational qualifications mentioned in the application form.
- (c) Experience Certificate(s) from the Head(s) of Organization(s) / Department(s) for the entire experience claimed, clearly mentioning the duration of employment (date, month & year) indicating the basic pay and consolidated pay. The certificate(s) should also mention the nature of duties performed/experience obtained in the post(s) with duration(s).
- (d) Persons serving in Govt. / Semi Govt. / PSUs / Universities / Educational Institutions should send their applications either THROUGH PROPER CHANNEL or should furnish a NO OBJECTION CERTIFICATE from the Competent Authority of the organization serving, at the time of interview otherwise they may not be allowed for interview. However, they can submit the advance copy of the application form.
- (e) Caste certificate by candidate seeking reservation as SC/ST/OBC/EWS shall be in the prescribed Performa only from the competent authority indicating clearly the candidate's Caste, the Act/Order, under which, the Caste is recognized as SC/ST/OBC/EWS and the village/town the candidate is ordinarily a resident of.
