### **Walk-in-Interview for Appointment of Temporary Faculty in the Department of CSE & ECE**

#### 1. ABOUT THE INSTITUTE

Indian Institute of Information Technology Ranchi is an autonomous institute setup by the MoE, Government of India, and Government of Jharkhand along with the industry partners Tata Technologies Limited, TCS and CCL on a Public Private Partnership.

MoE, Government of India has taken up the initiative to setup 20 new Indian Institutes of Information Technology (IIITs) on a Public Private Partnership Model. A major objective in establishing IIITs is to setup a model of education which can produce best-in-class human resources in IT and harnessing the multi-dimensional facets of information technology in various domains. While the number of students produced by these IIITs would be small, the impact they create would be great. The IIIT Ranchi is funded by Government of India (50%), Government of Jharkhand (35%) and Industry Partners (15%).

**2. Schedule of Walk-in-Interview:**

Applications are invited from academic personnel/professionals from Academic Institutes, R&D Labs and Industry in India or abroad for the Post of Temporary Faculty in IIIT Ranchi on temporary basis initially for one semester, which may be extended on semester to semester basis on recommendation of the HOD. Maximum duration of appointment in the entire career of a person shall be limited to five semesters with a consolidated emolument of ₹70,000/- per month for effective teaching and commitment to enhance the research activities in the Department. Eligible candidate may appear at the walk-in-interview with duly filled in application form along with all certificates in originals with one sets of photocopies. The prescribed application form is available on the Institute website.

**3. General Information:**

1. Candidates with less than or equal to 35 years age shall be preferred. However, maximum age limit is 60 years.
2. The post is purely on Temporary basis and it does not confer any right to claim either for subsequent employment or permanent post in future. Duration of the appointment shall be one semester to start and may be extended on semester to semester basis on the recommendation of the HOD. Maximum duration of appointment in the entire career of a person shall be limited to

- five semesters. The consolidated emolument is ₹70,000/- per month.
3. All qualifications, experience and age limit will be recognized as on the date of Interview.

  5. The Institute reserves the right to shortlist the number of candidates depending upon the number of applications received, the qualification, publication and written test, etc. The decision of the Selection Committee is final.

  8. The selected candidates will be required to join immediately.
  9. The hard copy of filled application form along with original certificates, one set of self attested photocopy of the certificates and one latest passport size color photographs have to be submitted at the time of interview.

  11. Canvassing in any manner would entail disqualification of the candidature.

  13. The candidate will be interviewed only after scrutiny of educational and experience certificates. Therefore, candidates must carry all the original testimonials.
  14. Selected candidates will be intimated through the Institute website/email.
  15. The institute reserves the right to fill or not to fill the post advertised.

  17. No TA / DA will be paid for attending the interview.
