Indian Institute of Information Technology Ranchi is an autonomous institute setup by the MoE, Government of India, and Government of Jharkhand along with the industry partners Tata Technologies Limited, TCS and CCL on a Public Private Partnership mode.

MoE, Government of India has taken up the initiative to setup 20 new Indian Institutes of Information Technology (IIITs) on a Public Private Partnership Model. A major objective in establishing IIITs is to setup a model of education which can produce best-in-class human resources in IT and harnessing the multi- dimensional facets of information technology in various domains. While the number of students produced by these IIITs would be small, the impact they create would be great. The IIIT Ranchi is funded by Government of India (50%), Government of Jharkhand (35%) and Industry Partners (15%) for its establishment.

The institute is managed by professionals from the area of academics and research, under the guidance of a Board of Governors of the Institute that has representatives of participating Industry partners, eminent academicians & researchers and representatives from Government. IIIT Ranchi will focus on applied research and education in IT and in selected domain areas. IIIT Ranchi will contribute significantly to the global competitiveness of key sectors of the Indian economy and industry. IIIT Ranchi is committed to academic excellence and good governance.

GENERAL INSTRUCTIONS

1. Candidates are requested to read the instruction carefully before filling up the online application. Candidates applying for more than one post are required to submit application for each post separately. Enclosures in support of application are required to be sent along with the online generated application.
2. Applicants are requested to go through all the instructions carefully and ensure that they fulfill all eligibility conditions. Their admission to all stages of the recruitment will be purely provisional and the final selection is subject to fulfilling the eligibility conditions. If at any subsequent stage, the information provided/claim made by the applicant is found to be false, his/ her candidature will be cancelled at any stage of the recruitment process and if appointed, services will be terminated without any notice or compensation.
3. Candidates should carefully fill up all the required details in the online application including age, education qualification, SC/ ST/ OBC-NCL/ EWS/ PwD certificates, experience certificate, the details of the pay scale, if applicable etc. If any of their claims is found to be incorrect, it will lead to rejection of their candidature.
4. The age limit, qualification and experience will be reckoned as on the last date of closing of online application i.e., 28th February 2026. Age relaxation in case of SC/ ST/ OBC-NCL/ Ex-servicemen/ PwD candidates against reserved posts will be followed as per Government of India norms.

5. As per the 17th Board of Governors meeting resolution no. BOG/MIN/17/2024-25/12, Age relaxation up to 56 years shall be admissible only to the persons (non-teaching staff) those are working/serving at IIIT Ranchi on Ad-hoc/Temporary/Contractual/Outsourced basis engaged through various service provider and institute daily wages basis having one year of service at IIIT Ranchi on the date of advertisement.
6. Persons currently serving in Govt./ Semi-Govt./ PSUs shall apply online and forward their application through proper channel or alternatively, they shall furnish a **NO OBJECTION CERTIFICATE** at the time of test / interview.
7. The institute reserves the right to set additional criteria for shortlisting and any other criteria deem fit by the Institute to restrict the number of candidates to be called for written/skill test/ interview to a reasonable limit based on the experience and its relevance, qualifications and level higher than the eligibility criteria prescribed in the advertisement. Fulfilment of qualifications per-se does not entitle a candidate to be called for test/ interview. The Institute reserves the right not to fill up the posts, cancel the advertisement in whole or in part without assigning any reason and the decision of the institute in this regard shall be final and binding on the applicants. No correspondence and personal inquiries shall be entertained.
8. Incomplete applications or application without relevant enclosures or without fee will be outrightly rejected. No Interim correspondence will be entertained and replied to.
9. Canvassing in any form will be treated as a disqualification for the post and cancellation of candidature.
10. No TA/DA will be paid for attending written test/ interview.
11. The candidates applying against the vacancies reserved for EWS must upload the Income and Asset Certificate valid for the year 2025-26 at the time of online application. The candidates claiming for OBC-NCL should upload a valid OBC-NCL certificate accordingly. The OBC-NCL certificate issued on or after 1st April 2025 shall be treated as a valid certificate for this purpose. Further, these candidates are also required to produce the valid EWS/OBC-NCL Certificates during document verification. The caste/category certificate should be submitted as per the Central Govt. format. The candidates claiming for OBC-NCL, SC and ST should note that reservation will be applicable only if the caste is available in the Central List notified by the Ministry of Social Justice and Empowerment, Govt. of India.
12. Original documents along with one set of self-attested copies will have to be produced at the time of test / interview for verification.
13. The applicants are advised/ required to visit the Institute website www.iiitranchi.ac.in regularly. All the information related to the recruitment will be uploaded on the website at every stage. The list of candidates shortlisted for further participation in the selection process such as test / interview etc. will be displayed on the above website. Separate communication through mail/post will not be sent.

14. The offer letter to the finally selected candidates shall be sent through e-mail only.
15. In case of any inadvertent mistake in the process of selection detected at any stage even after the issue of appointment letter, the Institute reserves the right to modify/ withdraw/ cancel any communication made to the candidates.

16. Mode of Selection for the advertised posts are tentatively as follows.

The Institute reserves the right to decide the mode of screening and testing the applicants for shortlisting and selecting. After entering the required details, complete the payment and take a printout of the payment receipt. Finally, enter the transaction details on the Samarth portal to complete the final submission.
