With reference to the IIIT Ranchi tender No. IIITR/2025/PUR/09 dated 15.12.2025, some amendments in the eligibility criteria have been carried out, which are as follows:

1. **FOR** : The Booksellers/Distributors/Vendors should have satisfactorily supplied print books to any 10 Government Universities- Central/State or Institutes of National Importance in last three financial years 2024-25, 2023-24, 2022-23 (satisfactory supply certificates along with relevant order copies should be attached).

**READ** : The Booksellers/Distributors/Vendors should have satisfactorily supplied print books to any 05 Government Universities- Central/State or Institutes of National Importance in last three financial years 2024-25, 2023-24, 2022-23 (satisfactory supply certificates along with relevant order copies should be attached).

2. **FOR** : The Booksellers/Distributors/Vendors should have a minimum average annual turnover of Rs. 5 crores in the last three (3) consecutive financial years 2024-25, 2023-24, 2022-23 (C.A. Certificate should be attached).

**READ** : The Booksellers/Distributors/Vendors should have a minimum average annual turnover of Rs. 2 crores in the last three (3) consecutive financial years 2024-25, 2023-24, 2022-23 (C.A. Certificate should be attached).

3. **FOR** : The Booksellers/Distributors/Vendors should have to enclose single highest value order for supply of print books to any Central/State Government University or Institute of National Importance along with Satisfactory Supply Certificate for particular order in each financial year 2024-25, 2023-24, 2022-23 (Order copies and satisfactory supply certificates should be attached). The average of 03 years single highest value orders has been taken for the selection of vendors.

**READ** : The Booksellers/Distributors/Vendors should have to enclose single highest value order for supply of print books to any Central/State Government University or Institute of National Importance along with Satisfactory Supply Certificate for particular order in each financial year 2024-25, 2023-24, 2022-23 (Order copies and satisfactory supply certificates should be attached). The average of 03 years single highest value orders will be taken for the selection of vendors. IIIT Ranchi reserves the right to select one or many suppliers for empanelment, i.e. IIIT will decide minimum or maximum number of vendors for empanelment. IIIT Ranchi reserves the right to avail the services from any of the empanelled vendors or directly from outside registered vendors/publishers/book sellers, if required.

4. **FOR** : The Booksellers/Distributors/Vendors should also enclose a DD/FDR/Bank Guarantee for Rs. 2,00,000/- (Rs. Two Lakh Only) in the form of Security Deposit in favour of "Registrar, IIIT Ranchi payable at Ranchi" which will be returned after expiry of the tenure without any interest or will be forfeited due to any loss to the Institute from the Booksellers/Distributors/Vendors.

**READ** : The Booksellers/Distributors/Vendors should also enclose a DD/FDR/Bank Guarantee for Rs. 50,000/- (Rs. Fifty Thousand Only) in the form of Security Deposit in favour of "Registrar, IIIT Ranchi payable at Ranchi" which will be returned after expiry of the tenure without any interest or will be forfeited due to any loss to the Institute from the Booksellers/Distributors/Vendors. This is not EMD amount. EMD amount is NIL. This amount can be deposited with application form or within 15 days from the letter of empanelment.

5. **Last Date of Bid Submission** : The last date of bid submission is extended up to **16<sup>th</sup> February till 5.00 PM**. Bids sent through any mode, i.e. Speed Post/Registered Post/Courier/By Hand should reach IIIT Ranchi by **16<sup>th</sup> February 2026 till 5.00 PM**.

6. **Other Terms & Conditions** : shall remain same.

Registrar
